BOARD OF ADJUSTMENTS COMMISSION – The commission consists of five (5) members, who shall be residents of the City and qualified by knowledge or experience to act in matters pertaining to the development of a City Plan and who shall not hold any elective office in the City Government. Full description can be found under Chapter 165.08 located at City Hall.

Two (2) vacancies with terms expiring on

BROADBANDS COMMUNICATIONS COMMISSION – The commission consists of five (5) members, who shall be residents of the City. The Commission has primary responsibility for the continuing administration of the cable TV franchise. Full description can be found under Chapter 23 located at City Hall.

LOCAL ACCESS CABLE CHANNEL COMMISSION – The commissions consists of Adult and Junior Division. Members of the Adult Division must reside within the city limits and members of the Junior Division must attend Lone Tree Community Schools. In addition to these members there shall be two current City council members appointed as City Council Liaisons for Cable TV and one Lone Tree Community School Liaison for Cable TV, as appointed by the Lone Tree Community School.. TREE BOARD COMMISSION – The commission consists of five (5) members, who shall be residents of the City. It is the responsibility of the Board to study, investigate, counsel, and develop a written plan for the care, preservation, trimming, planting, replanting, removal, or disposition of trees and shrubs in public areas working directly with Trees Forever.
